PARISH OF THE HOLY FAMILY LINDFIELD: ANNUAL SCHOOL BUILDING FUND CONTRIBUTION

We write to you, as parents of the children attending or who have recently attended our primary school, seeking a voluntary tax deductible contribution to the "*Parish of the Holy Family Lindfield School Building Fund*", in anticipation of the upcoming end of financial year. This year's appeal follows a successful fund raising last year before 30 June for the same purpose.

As most of you will appreciate, our school is located on constrained grounds, with limited building facilities and outdoor playing space for the approximately 300 children enrolled at the school. Consistently over the years, including most recently in a survey of parents conducted in 2009, parents have expressed a strong desire for the school and the Parish to look at options available to expand the facilities of the school for the benefit of the children. At least in the context of play space, that concern is supported by Local, State and Federal Government recommendations for the land size of primary schools.

While the Diocese will, as a general principle, assist schools financially in the building of new facilities through the Diocesan Building Fund (funded from the separate Diocesan building levy included in annual school fees), the funding of any acquisition of land for that purpose is a matter for the Parish and school communities. Those parents who have preceded you have themselves made significant contributions to the school to enable the current facilities to be built just on 10 years ago.

So, we ask you to consider making a tax deductible contribution to the building fund before 30 June 2011.

Of course, contributions are entirely voluntary. We hope that a tax deductible amount of at least \$300 per family will provide a useful start, although a greater contribution from those able to afford it would be much appreciated and accelerate the achievement of our vision.

Details for the making of any contributions are set in the attached contribution form. Contribution forms can be returned to the School Office preferably by Tuesday, 28 June 2011 (to allow for payments to be banked before 30 June 2011) and a tax receipt in the name of the person set out in the contribution form will be sent to you at the address identified in your contribution form.

We would encourage you to contribute generously.
